The Member, Delhi Commission for Protection of Child Rights being the Chairperson & Convener of the Inspection Team shall co-ordinate with all the Members and arrange for inspections of each Child Care Institution in their jurisdiction at least once in a quarter especially all NGO run homes whether Licensed or Unlicensed. The inspection visit shall be carried out by not less than 4 members.

The Convener of the Inspection Team shall develop a planner/roster in consultation with the other Team Members for the Inspection of CCIs well in advance and co-ordinate with all the Members.

The inspection committees shall visit and oversee the conditions in the institution and appropriateness of the processes for safety, well being and permanence, review the standards of care and protection being followed by the institutions, look out for any

incidence of violation of child rights, look into the functioning of the Management Committee and Children's Committee set up under rules 55 and 56 of these rules and give appropriate directions. The Member, DCPCR shall keep the record and monitor the Inspection visits and inform the Department of Women & Child Development. The report of the Inspection shall be shared with the Institution Incharge of the concerned home.

The membership of the officer in-charge/members shall terminate when he/she ceases to hold the office by virtue of which he/she was member and his/her successor to the officer shall become such member.
