

MINUTES OF THE MEETING OF GRANT-IN-AID COMMITTEE
HELD ON 22.3.12

A special meeting of the GIA Committee was convened and held on 22.3.12 at 03.30 P.M. under the Chairmanship of Director (WCD) to consider the GIA case of the NGO 'Ramola Bhar Charitable Trust (STOP), A-25, Chittaranjan Park, New Delhi under the scheme of 'Ujjawala' of the Ministry of Women & Child Development, Govt. of India, for the year 2011-12. The case was processed in view of the letter No. 15-2/2011-CP dated 16.3.2012 received in the Deptt. on 19.3.12 from the Senior Advisor, Ministry of Women & Child Development, Govt. of India requesting the State Govt. of NCT of Delhi to send them a report on it.
