COMMON RECOMMENDATORY OBSERVATIONS:

The GIA Committee observed that the above listed case is recommended to Ministry of Social Justice & Empowerment and Ministry of Women & Child Development, Govt. of India with the following common observations:-

- 1. In view of the fact that the Ministry of Social Justice & Empowerment, Govt. of India has decided State-wise notional allocation under different GIA schemes, the amount of GIA for the recommended cases may be decided as per the proportion of actual grant disbursed last year.
- 2. The quantum amount of GIA may be decided by the Recommendation Committee/Project Sanctioning Committee at Govt. of India after looking into the utilization of the previous grants as the case may be.
- 3. The Sanction be based strictly in accordance with norms of the scheme as applicable to the respective case.
