- (i) Findings reported by the inspecting team and other inputs given by the respective Distt. Officers, as briefly, inter alia, noted against each case;
  - (ii) Following relevant points on eligibility & experience requirements stipulated in the scheme & other guidelines:
    - ‘Guidelines For Assisting NGO/Voluntary Organizations’ of the Ministry of Social Justice & Empowerment, Govt. of India which states that “In order to be eligible for assistance, a Voluntary Organization should have been registered for a period of at least two years and should have been actively working in its sector for a period of two years. Such projects will not be taken up for assistance where the activities are proposed to commence after the project is sanctioned and funds released by the Ministry”;
  - (iii) Reports of separate investigation on different matters as forwarded by the Ministry.

Ministry. The final discussion and the decision of the GIA Committee on the case was pending for reports from the High Level Enquiry Committee in r/o a complaint of alleged rape/ sexual assault against a visually impaired girl in the NGO.

The consideration and decision, in detail, of the GIA Committee is as follows:

In the month of July'2012, the Deptt. of WCD received a letter vide No. 22-8(8)/2009-DD-II dated 17.7.12 and addressed to the Secretary of the Deptt. of WCD, from Under Secretary to Govt. of India, Ministry of Social Justice & Empowerment, Govt. of India requesting the Deptt. of WCD to confirm as to whether the organization 'Janta Adarsh Andh Vidyalaya,' Sadiq Nagar, was working satisfactorily during the year 2010-11 or otherwise and if anything adverse was found in recommending the proposal of organization".

Earlier also in Feb'12 the Deptt. of WCD, Govt. of NCT of Delhi had also received a copy of letter vide No. 22-8(8)/2009-DD-II dated 03.08.10 from the Director, Ministry of Social Justice & Empowerment, Govt. of India requesting the Deptt. of WCD to investigate into a complaint/ allegation received by the Ministry from one Sh. Anand Verma, R/O 54-B (DDA Flat), Masjid Moth, PH-2, New Delhi-110 048. However the copy of the complaint was not found enclosed with the said letter. Hence the Deptt. requested the complainant vide a speed post letter dated 05.03.12 to meet the Director on 14.03.12. However, the complainant did not turn up.

When the Deptt. received the abovesaid letter dated 17.7.12, it requested its concerned DO(South) to submit a detailed report on the matter while taking in to cognizance of the matter in r/o the complaint received by the Ministry from one Sh. Anand Verma by getting in touch with him. The request was made by VAC letter/UO No. F.31/VAC/DWCD/Misc.Matter/GOI/2010-11/14640 dated 21.08.12 and by a reminder of even No, dated 11.09.12.

A detailed report dated 06.02.13 since then, has been received from the O/o DO(South) in response to these above said UOs.

During the period intervening between the VAC letter/UO dated 21.08.12 and the report dated 06.02.13, and pursuant to persistent efforts by the DO(South) with Sh. Anand Verma for supplying a copy of the complaint, the Deptt. received the same from him alleging "rape of minor girl/blind in the said organization by yoga teacher for years".

In response to this complaint, the Director, Deptt. of WCD constituted a 'High Level Enquiry Committee' headed by Joint Director (Admn.) to investigate into the matter. The report signed on 18.3.13 has since then, been received by the Director, WCD, Chairman of the GIA Committee.

In view of both the reports before the GIA Committee, it is of the view of that, the functioning of the organization 'Janta Adarsh Andh Vidyalaya, Sadiq Nagar' has not

been without gross irregularities in r/o general day to day management of the institution resulting into a seemingly continued inconducive environment in the institution. It is of the view of that the said organization has not been functioning in a satisfactorily democratic and transparent fashion which should deserve recommendation for Govt. Grant-In-Aid. Hence the case for the year 2012-13 is not found suitable for recommendation.
