- Prepare State Action Plan for approval of State Mission Steering Group;
- Execution of approved State Action Plan.
- Review implementation and achievement of child related outcomes;
- Analysis of lagging districts and supportive actions;
- Finalization of working arrangements for inter-sectoral coordination;
- Coordination with NGOs/Donors/other agencies and organization;
- Review of expenditure;
- Release of funds to the District Societies as per Annual Action Plan;
- Establish Resource Group of Professionals to facilitate design and implementation of the core strategies; and
- Any other task assigned by the State Mission Steering Group.
