- Redress nutrition challenges through preparation of State Specific Strategies, analyses nutrition relevance of various programmes and strengthen the same and issue policy guidelines based on latest nutrition surveillance feedback.
- Appraisal of the proposal and schemes and approve them on the broad normative approved framework.
- Consideration and approval of Annual State Action Plan for ICDS Mission.
- Appraisal and review of implementation of Annual Action Plan and achievement of Child related outcomes;
- Suggest any mid course correction that may be required in the State mission strategy design framework.
- Ensure effective convergence of policy and administration among the various Department;
- Review the follow up action on decisions of the State ICDS Mission.
- Approval of proposals for institutional management reforms for ICDS in the State;
- Advise the State Empowered programme committee on policies and oversee programme implementation;
- Appraise recommendations of the SEPC related to proposals and schemes and approve them based on the broad normative framework.
- Appraise and approve recommendations of SEPC on hiring of experts and functionaries on a contractual basis for carrying out the activities under the ICDS Mission;
- Any other matter with policy implications affecting the nutritional status of the target group of this Scheme.

The meeting of the council will be held atleast once in year.
